DAMAGE WAIVER PROTECTION

We, KENMAC Rentals & Sales, agree to waive claim against Renter for damage to rented equipment, except as shown below, *provided the equipment is used in accordance with all terms and conditions of the rental contract and the Renter pays a fee equal to 8% of all rental charges.*

DAMAGE WAIVER does not apply under the following conditions:

- A) Loss or damage as a result of theft, vandalism, or malicious mischief.
- B) Loss or damage to accessories such as air hose, tool steel, electric cord, blades, welding cable, liquid fuel tanks and other similar items.
- C) Loss or damage caused by willful neglect, misuse or abuse.
- D) Unexplained loss or mysterious disappearance.
- E) Theft, conversion or other dishonest act on any person or any persons in the service of employment of the lessee whether or not occurring during the hours of such service or employment.
- F) Equipment left unsecured. Equipment must be secured in a fenced area, building or locked with hi-test chain when left unattended. Equipment must also be secured properly during transportation at all times.

Notes: China and glassware items are covered by DAMAGE WAIVER *provided broken or damaged items are returned*. Missing items are not included, and will be charged at the regular replacement price.
